

HUCK'S METALS FAMILY GIFT CARD SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO PLAY OR WIN A PRIZE.

1. **HOW IT WORKS:** From August 9th– October 3, 2020 or while supplies last (“the Sweepstakes Period”), contestants may visit participating Huck’s. (“Sponsor”) locations and enter for a chance to win one of the prizes specified below. 2. **ELIGIBILITY:** Only open and offered to legal U.S. residents who reside in Indiana and who are 18 years of age or older at the time of entry and who are, or who register to become a Rewards member with a valid email or phone number on file (“Contestant”).
