

Huck's Hoosier Lottery Holiday Fuel Promotion Official Rules

1. HOW IT WORKS: From November 5, 2021-December 25, 2021 ("the Promotional Period"), contestants may visit participating Huck's ("Sponsor") locations in Indiana and enter for a chance to randomly win up to .25 cents off of a fuel purchase. The odds of being selected as a winner depend upon the number of qualifying tickets purchased throughout the duration of the promotion.

2. ELIGIBILITY: Only open and offered to legal U.S. residents who reside in Indiana and who are 18 years of age or older at the time of entry. Employees of Sponsor, the State Lottery Commission ("Commission") and/or IGT, the integrated services provider of the State Lottery Commission of Indiana (together with the Commission, "Hoosier Lottery"), and immediate family members and individuals residing in the same household as the above are not eligible to participate. Void where prohibited.

3. HOW TO PLAY: Customers who purchase a \$5 Holiday Bonus or \$10 Festive \$500s Scratch-off ticket using their Huck's Bucks Bigg Rewards Card could win a random fuel rewards for up to .25 cents off their fuel purchase.

Prizes will be awarded randomly, and number of winners will be determined based on the number of qualifying tickets purchased using the customers enrolled Huck Bucks Bigg Rewards. Prizes will be awarded through the Huck's Bigg Bucks Rewards App.

4. HOW TO PLAY WITHOUT PURCHASE: To enter by mail without a purchase, print your complete name, complete mailing address (no P.O. boxes), city, state, zip code, date of birth (mm/dd/yyyy), valid daytime and evening phone numbers, and email address, address of your local Huck's location, and the words "Huck's Hoosier Lottery Holiday Fuel Promotion" on a 3" x 5" card and mail the entry with first-class postage to: Huck's Hoosier Lottery Holiday Fuel Promotion, 1311 W. Main St., Carmi, Illinois 62821. Limit one hundred (100) entries per household per day. Each entry must be mailed in a separate envelope, and all entries must be received by Sponsor by 11:59 PM on December 27, 2021. Failure to comply with this or any other Official Rules will result in disqualification. No mechanically reproduced entries are permitted. Illegible or incomplete entries are void. Not responsible for lost, late, damaged, postage due, misdirected entries or entries not received by the entry deadline. The chances of winning for a mail in entry are equal to the chances of winning via in-store coupon entry. The number of random drawings for contestants entering via mail in entry shall be in proportion to the total number of mail-in entries received.

5. PRIZES AND APPROXIMATE RETAIL VALUES:

- Random rewards of 25, 20 and 15 cents off your fuel purchase.

- Up to 25 gallons

6. CONDITIONS OF PARTICIPATION: The prizes set forth in these Official Rules will be given to the winning Contestants at a designated Huck's store. Taxes on the prize

are the sole responsibility of the winner. No more than the number of prizes set forth in these Official Rules will be awarded. Entries not legitimately obtained and/or used in accordance with these Official Rules are void. Use of any automated system to participate is prohibited and will result in disqualification. Potential winning entries are subject to verification by Sponsor, whose decisions are final and binding. All federal, state, and local laws and regulations apply. Contestants agree to be bound by the terms of these Official Rules and by the decisions of Sponsor, which are final and binding on all matters pertaining to this promotion. Acceptance of a prize constitutes permission for Sponsor, the Hoosier Lottery, and those acting under their authority to use a winner's name, photograph, voice and/or likeness and prize information for advertising, trade and promotional purposes without further compensation, in all media now known or hereafter discovered, worldwide on the World Wide Web, without notice or review or approval. Sponsor is not responsible for any typographical or other error in the printing of the offer, administration of the promotion or in the announcement of the prize.

LIMITATIONS OF LIABILITY: Entrants in the Promotion hereby: (a) release Sponsor, the State Lottery Commission of Indiana, and IGT Indiana, LLC, and their respective officers, directors, employees, agents, advertising and promotional agencies and representatives (collectively, the "Released Parties") from any and all liability for any loss, harm, damages, costs, or expenses, including without limitation property damages, personal injury, and death arising out of participation in this Promotion or any Promotion-related activity, or the acceptance, possession, use, or misuse of any prize, and claims based on publicity rights, defamation, invasion of privacy, and merchandise delivery; and (b) indemnify, hold harmless, and defend the Released Parties from and against any and all liability or loss and against all claims or actions identified in the foregoing Section 7(a) or relating thereto.

The Released Parties assume no responsibility for error, omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials, or for technical, network, wireless, telephone equipment, electronic, computer, hardware, or software malfunctions of any kind, or inaccurate transmissions of or failure to receive entry information by Sponsor on account of technical problems or traffic congestion on the Internet or via mobile device transmission or any combination thereof. No responsibility is assumed for any injury or damage to any entrant's or any other person's computer/mobile device related to or resulting from downloading any materials in the Promotion, for any unavailability of telephone lines, connections, or cellular telephone service, or for any other technical malfunctions that may interfere with any entrant's attempt to enter. Any attempt to deliberately damage any service or website or to undermine the legitimate operations of the Promotion may be a violation of civil or criminal laws, and Sponsor reserves the right to disqualify and seek damages from any such person to the fullest extent of the law. Sponsor reserves the right in its sole discretion to modify, suspend, or terminate the Promotion in whole or in part for Sponsor for any reason without prior notice. The Promotion and prize are provided "as is" without warranty of any kind, either express or implied, including without limitation the implied warranties of merchantability, fitness for a particular purpose, and non-infringement.

In no event will the Released Parties be responsible or liable for damages or losses of any kind, including direct, indirect, incidental, consequential, or punitive damages arising out of your acceptance, possession, use, or misuse of the prize or access to or use of the Promotion or information relating to the foregoing.

8. GENERAL CONDITIONS: Federal, state, local, and other tax obligations arising from this Promotion, including obligations arising out of winning a prize, will be the sole responsibility of each prizewinner. Prizes are non-transferable, and no substitution, cash redemption, assignment, or transfer of any prize is permitted, but Sponsor reserves the right to substitute a prize of equal or greater value if an offered prize is unavailable for any reason. Unclaimed prizes may be awarded to alternate entrants.

Except where prohibited by law, any winner's acceptance of a prize constitutes permission for Sponsor to use the prize winner's name, photograph, likeness, statements, biographical information, voice, and address (city and state) worldwide and in all forms of media, in perpetuity, without further compensation.

All potential winners are subject to verification, including without limitation verification of eligibility, compliance with these Official Rules, and completion of release forms. In addition, Sponsor reserves the right to require a confidential background check upon a potential winner to help ensure that the use of any such person in advertising or publicity for the Promotion will not bring Sponsor into public disrepute, contempt, scandal, or ridicule or reflect unfavorably on the Promotion or Sponsor, as determined by Sponsor in its sole discretion, and that the awarding of the prize to the potential winner will not violate applicable U.S. laws or regulations. In addition, Sponsor reserves the right to require the potential winner to submit the information necessary for the confidential background check and authorize the check through electronic means designated by Sponsor to expedite the process of verifying the potential winner as eligible to receive the prize. If a potential winner fails to submit the information for the background check and authorize the check electronically where instructed to do so by Sponsor, or Sponsor determines in its sole discretion that the awarding of the prize may violate applicable U.S. laws or regulations; Sponsor may disqualify the potential winner. If attempted notification is returned as undeliverable, if a potential winner is not verified as eligible or cleared via the background check, or if a potential winner is otherwise determined to be ineligible to receive a prize, the prize will be forfeited and may be awarded to an alternate winner in Sponsor sole discretion.

The Promotion is void outside of Indiana and where prohibited by law and is subject to all applicable federal, state, and local laws and regulations. This Promotion and these Official Rules will be governed by the laws of the State of Indiana. Any court of competent jurisdiction sitting within the State of Indiana will be the exclusive jurisdiction and venue for any dispute arising out of or relating to this Promotion and these Official Rules.

If the Promotion is challenged by a legal or regulatory authority, Sponsor reserves the right to discontinue or modify the Promotion, or to disqualify entrants residing in the affected geographic areas. In such event, the Released Parties will not have any liability to any entrants who are disqualified due to such action.
